Provide the following:</p> <ul style="list-style-type: none"> Signed and notarized Affidavit of Residency (this form may be obtained through the school secretary or downloaded from the Dinwiddie County Public Schools website)
<p>At the discretion of the Principal or designee, if evidence of a parent/guardian's residence within the District is still insufficient, the Principal or designee shall submit a referral to the school social worker or the Office of Student Services. The School District may take whatever actions are necessary to verify the parent or guardian's residence within the District. In cases of students residing in a temporary location or who otherwise are considered homeless, see board policy JECA - Homeless Students.</p>
