At the discretion of the Principal or designee, if evidence of a parent/guardian's residence within the District is still insufficient, the Principal or designee shall submit a referral to the school social worker or the Office of Student Services. The School District may take whatever actions are necessary to verify the parent or guardian's residence within the District.
