Provide the following:</b></p> <ul style="list-style-type: none"> <li>• Utility Bill – Gas, electric, water (current within 30 days) for the owner or lessee**</li> </ul> <p><b>3. Provide any three (3) of the following:</b></p> <ul style="list-style-type: none"> <li>• Current Virginia driver’s license or Virginia identification card with the address of the residence;</li> <li>• Current bank statement which evidences the location of the legal residence;</li> <li>• Previously issued W-2 or Form 1099, pay stub which evidences the location of the legal residence;</li> <li>• Voter registration documentation from Dinwiddie County which evidences the location of the legal residence;</li> <li>• A current motor vehicle registration (tag receipt) which evidences the location of the legal residence;</li> <li>• Official correspondence with an address from a government agency.</li> </ul> <p><b>4. Provide the following:</b></p> <ul style="list-style-type: none"> <li>• <b>Signed and notarized Affidavit of Residency</b> (this form may be obtained through the school secretary or downloaded from the Dinwiddie County Public Schools website)</li> </ul>
<p>At the discretion of the Principal or designee, if evidence of a parent/guardian's residence within the District is still insufficient, the Principal or designee shall submit a referral to the school social worker or the Office of Student Services. The School District may take whatever actions are necessary to verify the parent or guardian's residence within the District.
