#### **Expenditure Reports**

The expenditure **reports** from June 2020 were presented and approved.

#### Approval of Minutes of June 9, 2020

The meeting **minutes** from the previous board meetings were approved.

#### Board Matters Community Eligibility Provision (CEP) Program

Carey Athey, Director of School Nutrition Services, shared information about the **Community Eligibility** Program. This program allows schools with a high percentage of eligible children to serve free meals to all enrolled students for a period of up to four consecutive school years. He requested that Dinwiddie Elementary, Midway Elementary, Southside Elementary, Sunnyside Elementary, Sutherland Elementary, and Dinwiddie Middle participate in this program beginning 2020-2021. The board approved this request.

#### **Health Insurance**

Chris Wells, Benefits Coordinator, presented the recommendation for the new <u>Health Insurance plan</u> for Local Choice. He also shared the insurance rates for 2020-2021, which will take effect on October 1. The board approved this request.

#### **School Bus Purchases**

The School Board approved the <u>request</u> to purchase 7 buses using the CARES Act funding provided to us from Dinwiddie County that was presented by Christie Fleming, Director of Finance, and Edward Tucker, Director of Transportation.

#### **Roof Bid Award**

The School Board approved the **<u>Roof Bid Award</u>** presented by Christie Fleming, Director of Finance, and Jimmy Davis, Director of School Facilities. The roof projects will be for Dinwiddie Middle School and Southside Elementary School.

#### Nomination for VSBA Regional School Board Member of the Year

The Virginia School Boards Association seeks to recognize one **outstanding school board member** from each of the nine VSBA regions who exemplifies local involvement in promoting student achievement. Nominees must be or have been a board member serving on a VSBA member school board within the preceding 12 months ending June 30, 2020. The VSBA panel of judges will accept one nomination from each school board, and that nomination must be based on a discussion by and unanimous vote of the school board. The announcement of the winners and presentation of award plaques will be made during the VSBA Annual Convention in November. The board nominated and approved Ms. Barbara Pittman.
