PART I: SCHOOL PARENT AND FAMILY ENGAGEMENT PLAN **REQUIRED** COMPONENTS

- Parents will be surveyed as to the location, time of day, and topics of interests for meetings.
 - Parents will be informed through verbal and written communication about transportation and/or child care.

 - Parents will be invited to attend meetings at Dinwiddie Elementary School biannually. Invites will be sent in the parents native language.
 - Parents will be invited to attend Family Nights at Dinwiddie Elementary School at least twice annually. Invites will be sent in the parents native language.
 - Parents will be surveyed as to the location, time of day, and topics of interests for meetings. All communications will be sent in the parents native language.

- F. Provide parents of participating children:
- timely information about programs under this part;
 - a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet;
 - if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.
- The plan will be distributed annually in the fall and spring to the parents of participating children.
 - The plan will be available on Dinwiddie County Public School’s division website under Elementary Education & Title I under Title I.
 - The curriculum will be available on Dinwiddie County Public School’s division website under Elementary Education & Title I under Elementary Curriculum.
 - The Testing Schedule will be on Dinwiddie Elementary’s website under Family Resources.
 - Parents have access to Infinite Campus (Student Information System) to view assessments and grades.
 - Parents will receive timely information on expected proficiency levels through communication sent home from teachers and Infinite Campus.
 - Open communication exists between the school and home; parents will have opportunities to attend Parent/Teacher conferences twice annually; Student Success Teams meetings as needed; and, request additional conferences as needed.
- G. If a schoolwide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the district.
- Parents will participate in the decision-making process when updating and revising the schoolwide plan annually.
 - The plan will be distributed each fall and spring to the parents of participating children.
 - The plan will be available on Dinwiddie County Public School’s division website under Elementary Education & Title I

 - Parents will be informed of the Parent Resource Center located in the Reading Room of DES. This center provides books, games, and other materials to help parents help their child with academic skills.
- Provide professional development to teachers, specialized instructional personnel, and other staff on the value of parents and their communities to increase academic achievement.
 - Teachers and staff will be provided with professional development activities focused on parent and family engagement (e.g., faculty and staff meetings, parent & family engagement policies, PAC meetings, division website, newsletters, flyers, and emails).
- Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parent engagement.
 - Parent engagement programs and activities are coordinated with other programs (e.g., Literacy Nights, Book Bingo, Donuts with Grown Ups, Reading Month, Read for the Record, Summer Reading Challenge, Scholastic Book Fair).
 - PAC meetings will be held at Dinwiddie Elementary at least bi-annually.
 - Parents will be invited to division PAC meetings held at least bi-annually.
 - The Title I Parent Resource Center is located in the Reading Room, and parents are informed of resources available each fall and throughout the year at Title I events.

- Ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand.
 - Communication will be provided to parents in a language easily understandable to them.
 - Parents will be made aware of who to contact with questions about programs or events.

The following are allowable activities:

- 1) May involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training.
 - a. Parents may be involved in the development of training for teachers, principals, and other educators by attending PAC meetings at Dinwiddie Elementary and the division.

 - a. Funds will be made available for literacy training if the district has exhausted all other available funding sources.

 - a. Expenses, including transportation and childcare costs, associated with ensuring parents participation in school-related meetings and training sessions may be covered

 - a. Meetings will be scheduled at various times to maximize parent and family engagement participation.
 - b. Parents will be surveyed twice a year as to the preferred time and place for parent and family engagement activities.
