Parent and Family Engagement Plan

 - a description and explanation of the curriculum in use at the school, the forms of academic
 assessment used to measure student progress, and the proficiency levels students are expected to

- if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.
- 1. The plan will be available on Dinwiddie County Public School's division website under Elementary Education & Title I under Title I.
- 2. The curriculum will be available on Dinwiddie County Public School's division website under Elementary Education & Title I under Elementary Curriculum.
- 3. The Testing Schedule will be on Sunnyside Elementary's website under Family Resources.
- 4. Parents have access to Infinite Campus (Student Information System) to view assessments and grades.
- 5. Parents will receive timely information on expected proficiency levels through communication sent home from teachers and Infinite Campus.
- Open communication exists between the school and home; parents will have opportunities to attend Parent/Teacher conferences; Student Success Team meetings as scheduled; and, request additional conferences as needed.
- G. If a schoolwide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the district.
 - 1. Parents will participate in the decision-making process when updating and revising the schoolwide plan annually.
 - 2. The plan will be available on Dinwiddie County Public School's division website under Elementary Education & Title I.

 - Teachers and staff will be provided with professional development activities focused on parent and family engagement (e.g., faculty and staff meetings, parent & family engagement policies, PAC meetings, division website, newsletters, flyers, and emails).
- Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parent engagement.
 - Parent engagement programs and activities are coordinated with other programs (e.g., Literacy Nights, school-wide reading incentive programs, Read for the Record, Summer Reading Challenge).
 - o PAC meetings will be held at Sunnyside Elementary at least twice yearly.
 - o Parents will be invited to division PAC meetings held at least bi-annually.
 - The Title I Parent Resource Center is located in the Reading Room, and parents are informed of resources available.
- Ensure that information related to school and parent programs, meetings, and other activities is sent to the parents. of participating children in a format and, to the extent practicable, in a language the parents can understand.
 - o Communication will be provided to parents in a language easily understandable to them.

The following are allowable activities:

- 1) May involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training.
 - a. Parents may be involved in the development of training for teachers, principals, and other educators by attending PAC meetings at Sunnyside Elementary and the division.
